

Terms and Conditions

IMPORTANT CONTRACT TERMS

Fall 2025/Spring 2026 Academic Year:

The dining plan chosen is for the **entire academic year**. The full value of the requested dining plan will be billed to the student's UVA Financial Services account at the beginning of the fall semester **and again** for spring semester. As the student will be billed each semester, the student will receive a set number of meals and Dining dollars each semester. Unused Dining Dollars and unused meals on active plans are forfeited at the end of the academic year (end of dining service on May 8, 2026).

- **I understand the dining contract is one continuous plan for the entire academic year (two semesters). I will be billed once in fall and again in spring, except in cases of the Block 25, Block 10 or Additional Dining dollars. Prices reflected on our website are the dining charges that will be billed to me each semester of the contract period.**
- **I understand that if I sign up for the meal plan in spring, and did not have a plan in fall, then I will be billed for the spring semester only.**
- **I understand unused meal swipes from fall do not roll over to spring if I choose to reduce my dining plan to a plan with fewer meals or cancel my plan.**
- **I understand unused meal swipes do carry over from fall to spring if, and only if, I remain in the original meal plan contract for spring, or increase the number of meals in spring.**
- **I understand unused Dining Dollars from the fall semester are available for use during spring semester if I continue with any annual meal plan through spring.**
- **I understand all unused Dining Dollars and unused meals are forfeited immediately upon dining plan cancellation.**
- **I understand cancellation of meal plan will incur pro-rated charges and/or fixed costs if any part of the plan is used after the dining halls open in either semester.**

Changes: Unless I have been defaulted into a meal plan contract, I understand that I may voluntarily reduce or cancel my dining plan via this website no later than September 3, 2025, for fall semester, and between November 26, 2025 and January 21, 2026, for spring semester. Downgrade requests or cancellations will not be accepted after these deadlines. I understand I may upgrade at any time to a dining plan with more meals or purchase additional Dining Dollars. I understand non-payment does not constitute dining plan cancellation.

All Dining Dollar funds and meal plans purchased for use in UVA Dine facilities are for the personal use of the owner of the account or plan only and are non-transferable. Dining Dollars and meals cannot be used for a gift, reward card or gift certificate. Neither meals nor Dining Dollars may be sold, and meal plan holder must accompany guest when using guest meals. Except as otherwise expressly stated in these terms, all Dining Dollar funds and meal plans are non-refundable and will expire at the earlier of: the last day of enrollment in UVA, the last day of enrollment in the dining plan, or the last day of the spring semester.

Unused portions of the Dining Plans (meals and Dining Dollar funds) are non-refundable. Unused *Additional* Dining Dollars voluntarily added in excess of the standard Dining with your meal plan is refundable with written request to dining@virginia.edu any time before May 8, 2026.
