MEAL PLAN TERMS AND CONDITIONS

Summer 2024:

Please review the summer dining schedule <u>before</u> signing up for a summer dining plan. Summer dining hours are limited and may not be compatible with your intensive summer class schedule. Check hours on our <u>website</u> for specific hours and days.

Please reserve the dining plan(s) indicated for the 2024 summer sessions. I understand that the full value of the requested dining plan will be charged to my SIS account. I understand that I may sign up for as many meal plans or add as many additional summer flex dollars to my summer meal plan as I will need throughout the summer sessions. I understand that unused summer Flex Dollars and unused summer meals are non-refundable. I confirm that my program of study is compatible to having and using a summer meal plan during the *limited* summer dining schedule. I understand that early terminations are not permitted, except in cases of early withdrawal from summer academic sessions, and that non-usage or non-payment of the plan does not provide an exception to this policy. Unused summer Flex Dollars and unused summer meals are forfeited at the end of summer session 3 and do not roll over to any other term.

 - Fresh Food Company (only open during July Orientation session meal periods)
 - o West Range Café (closed 05/20, 05/27, 06/19 & 07/04)

 - o Za'atar at Bonnycastle starting 05/28 (closed 05/27, 06/19 & 07/04)
- Summer Flex dollars may be used at the locations listed above as well as:
 - o Saxby's at Shannon Library (closed 05/27, 06/19 & 07/04)
 - o Subway at PAV XI (Newcomb Hall) through 05/24 (closed 05/27 through 08/09)
 - o POD at Newcomb (closed 05/27, 06/19 & 07/04)
 - o Delivery from Papa Johns on Ivy Road open year round

Changes: I understand that any request for changes to my summer dining plan contract must be submitted to the Dining Administrative Office by e-mailing the Dining administrative office at dining@virginia.edu before August 9, 2024. If a cancellation request is approved there may be a \$50 early termination fee and pro-rated charges. Change requests sent to any other offices (including Student Financial Services) are not accepted and cannot be honored.

All Flex Dollar funds and meal plans purchased for use in U.Va. Dining facilities are for the personal use of the owner of the account or plan only and are non-transferable. The Flex Dollars and meals cannot be used for a gift, reward card or gift certificate. Except as otherwise expressly stated in these terms, all summer Flex Dollar funds and meal plans are non-refundable and will expire at the earlier of: the last day of enrollment in UVA, the last day of enrollment in the summer dining plan, or the last day of summer session 3.

Dining Plans and Flex Dollar funds are non-refundable.

Unused <u>Additional</u> Flex Dollars voluntarily added to your summer account are refundable with written request to <u>dining@virginia.edu</u> by August 9, 2024.
